- (2) any easements or profits a prendre described hereunder.

The direction of the flow of water through the drainage easements shown on the plan is indicated by arrows.

Covenants

The owner or owners of each lot shown on the plan covenant with Fenshaw Pty Ltd, Azar Building & Construction Services Pty Ltd and Key Sites Pty Ltd ("the Vendor") and the owners for the time being of every other lot shown on the plan to the intent that the burden of these covenants may run with and bind the covenantor's lot and every part thereof and that the benefit thereof shall be annexed to and devolve with each and every other lot shown on the plan to observe the following stipulations:

- (a) Not to erect or place or permit to be erected or placed on such lot a building or structure having a roof other than of clay tiles, cement tiles, slate or non-reflective surfaced corrugated iron.
- (b) Not to erect or place or permit to be erected or placed on such lot any building or structure having wall cladding of a reflective nature or wall cladding made of unpainted metal.


