

IMPORTANT INFORMATION PLEASE READ CAREFULLY

Notice is hereby given that Rates and Charges levied by Noosa Shire Council, by the virtue of the "Local Government Act" and amendments thereto, on land described on the front of this Rate Notice for the period stated (and Arrears of Rates and Charges, with interest if any), are now due, and hereby required to be paid by the due date of this Notice.

It is the owner's responsibility to confirm that all rates and charges are correct at the time of issue of the Rate Notice. Adjustments to rates and charges levied in prior financial years will only be done in exceptional circumstances. To ensure that your property is in the correct general rate category please refer to the enclosed Rating Category Statement, which has descriptions of all differential general rate categories for Noosa Shire Council. If you have queries about other rates and charges please refer to Council's Revenue Statement, available on Council's website, or contact Council's customer service centre for more information.

CREDIT CARD SURCHARGE FEE

A credit card surcharge fee of 0.5% applies to all payments made using MasterCard or Visa. This includes online payments, phone payments and payments made in person at Council's office. Please also note that property owners are no longer able to BPAY from their credit card.

DISCOUNT

An early payment discount is offered by Council. Discount is only allowed where ALL Rates and Charges are paid in FULL by the DUE DATE of this Rate Notice. Please note: if you make your rate payment on the due date after your financial institution's cut off time, the payment will be processed the following business day. This may result in loss of discount. If you are unsure of your internet or phone banking cut-off times please contact your financial institution directly.

INTEREST

Interest charges of 12.35% per annum, compounding daily, will apply to any Rates and Charges outstanding after the due date of this notice.

PAYMENT ARRANGEMENTS

There are a number of payment arrangement options available if you cannot make payment in full by the due date of this notice. These payment arrangement options can be found by visiting Council's website at www.noosa.qld.gov.au or alternatively by contacting Council's customer service centre. Please note that should you not pay this notice in full by the due date and you have not made application for a payment arrangement Council may proceed with debt recovery action against you.

PENSION CONCESSION

If you hold a Pensioner Concession Card or Veteran Affairs Gold Card and if this property is your principal place of residence you may be entitled to State and Council funded concessions on your Council Rates. PROPERTY SALES/NEW OWNERS

EMERGENCY MANAGEMENT LEVY

The Emergency Management Levy is a State Government charge, levied in accordance with the Fire and Emergency Services Act 1990 and supporting regulations. Please refer to these documents, copies of which are available on Council's website, for full details of property classifications and contribution amounts.

CHANGE OF ADDRESS

Council requires notification of any change of postal address from rate payers. This information will be accepted over the phone, in writing or via email. You must state your full name and all property numbers to which the change applies.

WASTE LEVY

On 1 July 2019 the State Government introduced a waste levy to properties across the State to encourage the reduction of waste generation and grow the resource recovery and recycling industry. Historically residential properties had been fully subsidised by State Government, however from 1 July 2023, the State Government will begin to progressively unwind the full subsidy on domestic waste. Consequently residential property owners will now see this additional waste levy charge included on their rate notice.

SHORT STAY LETTING AND HOME HOSTED ACCOMMODATION LOCAL LAW

The Short Stay Letting and Home Hosted Accommodation Local Law commenced on 1 February 2022. Owners of properties undertaking short stay letting or home hosted accommodation must lodge an application for approval under the local law, unless located within the local law exclusion area. 
