# Rates and Payment Information

Notice is hereby given that the rates and charges are levied by the Scenic Rim Regional Council by virtue of the Local Government Act on land described for the period as stated on the Rate Notice.

## DISCOUNT

Discount of 5 per cent will be allowed on current general rates only if the total amount of all rates and charges, including overdue amounts, is paid within thirty-one (31) days from date of issue shown on the rate notice. *Please consider adequate processing time for allowing discount.* For internet or phone payments, please refer to your financial institution for transaction cut-off times.

## OVERDUE

Where overdue appears on the front of this notice, some items included in the overdue may be non-rate items and therefore non-payment of these items will not affect discount being claimed.

## LEGAL ACTION

Rates and charges are payable on or before the due date. Overdue rates may be recovered by legal process.

## PENSIONER SUBSIDY

Council administers the State Government Pensioner Rate Subsidy Scheme in accordance with guidelines determined by the Department of Families, Seniors, Disability Services and Child Safety. If you consider you may be eligible download a pensioner subsidy application form on Council's website or contact Council for further details.

## STATE WASTE LEVY

Council will receive an annual payment of \$1,506,894 from the State Government to mitigate any direct impacts of the State Waste Levy on households in Council's area.

## INTEREST

Council charges interest at the rate of 12% pa on overdue rates in accordance with the *Local Government Act and Local Government Regulation*. The calculation of interest is undertaken on monthly rests with the accrual commencing on the first day rates become overdue and are levied on the first business day of each month.

## OVERSEAS

Ratepayers resident overseas should forward remittances by either electronic banking or Bank Draft in Australian currency to avoid short payments.

## CHANGE OF OWNERSHIP

Notification of Change of Ownership must be submitted to Titles Queensland. If this property has been sold, please forward this notice to the new owner.

## EMERGENCY MANAGEMENT LEVY

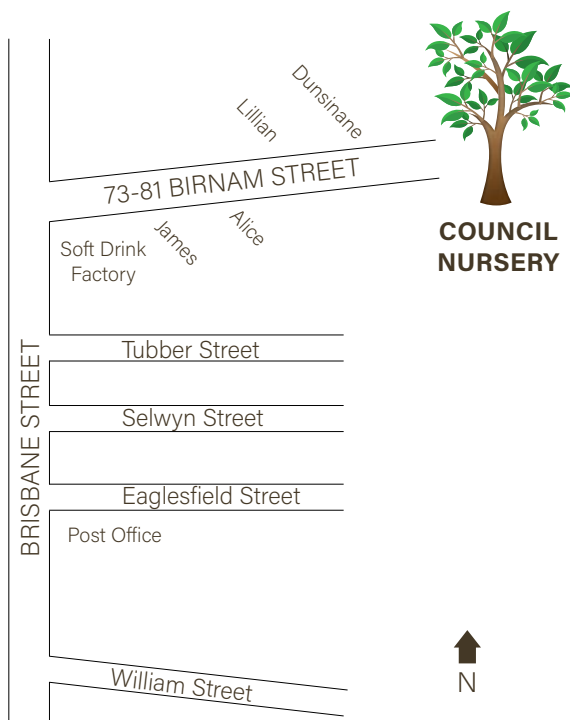

## Managing potted plants in a fire ant biosecurity zone

The Queensland Government has advised that, effective from 27 May 2020, the Beaudesert area is within Fire Ant Biosecurity Zone 2. Council's Beaudesert Nursery is therefore required to comply with the Queensland Government's Biosecurity Regulation 2016 for the way in which potted plants must be managed in fire ant biosecurity zones.

Accordingly, all potting material in the Nursery is chemically treated and stored as required by the Queensland Government (for full details of the requirements, please refer to the Fire Ant Carrier Fact Sheet, Managing potted plants in a fire ant biosecurity zone, which can be downloaded at Managing potted plants in a fire ant biosecurity zone or available by contacting the program on 13 25 23).

Should you have chemical sensitivity or concerns regarding any of the products mentioned in the fact sheet, please take appropriate precautions to eliminate or minimise contact with the potting material associated with the plants provided.
