- (a) "THAT the Whakatane Borough Council in exercise of the powers conferred on it by Section 186 (1) (b) of the Municipal Corporations Act 1954 permit the laying off of a street of a width throughout its length of less than 66 feet but not less than 50 feet provided that when any new buildings are erected or any buildings are rebuilt or re-erected on the land having frontage to any part of that street no part of any such building shall stand within a distance of 8 feet of the side line of such street the said narrow street being shown as Lot 15 on a Plan of Subdivision lodged for deposit in the Land Registry Office at Auckland as No. S. 6254 of part Allotment 301, Parish of Waimana for the registered owner Samuel Kenneth Schofield."
- (b) "THAT Public Notice be given in the Whakatane Beacon on 12th February, and 4th March, 1960, and that the above resolution be submitted as a Special Order Resolution to the Ordinary Meeting of the Council to be held on the 21st day of March, 1960-for confirmation."
