I, CHRIS WATT, Authorised Officer of the Western Bay of Plenty District Council, hereby certify that by way of resolution passed under delegated authority on 12th May 2016, the following condition was Imposed on the subdivision consent for Lot 2 Deposited Plan 474307:

  - THAT the consent holder shall provide to the Council's Compliance b) Officer notice of the date remediation works are to commence. This notice shall be received by the Council no less than 2 weeks prior to the commencement date and shall include the following details:

- name and telephone number of the project manager, contactor and site owner;
- site address to which the consent relates
- activity to which the consent relates
- expected duration of works.
- c) THAT the site shall be reinstated to an erosion-resistant state within 1 month after works are completed.
- d) THAT within 2 months of the remedial work being completed, and prior to any building on site, the consent holder shall provide to Council a site validation report as recommended by the approved Remedial Action Plan, Section 12.0. The report shall be prepared by a person who is suitably qualified and experienced in contaminated land management (as determined by the Council's Chief Executive Officer or duly authorised representative).
