

SCHEDULE B

- 1. THE transferee covenants in respect of the land hereby transferred with the transferor in respect of those lots on Deposited Plans S 25370 and S 25371 (excepting the land hereby transferred) which are at present registered in the transferor's name, and with the respective registered proprietors of those lots on Deposited Plan S 25370 and S 25371 which are no longer registered in the transferor's name all of which lots are hereinafter called "the other lots" to observe in perpetuity the restrictive stipulations set out in schedule C to the intent that the land hereby transferred shall be forever subject to this covenant.
- 2. THE transferor covenants with the transferee to obtain from the purchasers of each of the other lots execution of a like covenant in respect of each such lot with the transferees for the benefit of every part of the land hereby transferred, to observe in perpetuity the said restrictive stipulations.

3. THE transferor shall not be liable nor be called upon to erect or repair or contribute towards the cost of erection or repair of any boundary fence between the land hereby transferred and any land now owned by the transferor adjoining thereto but this proviso shall not enure for the benefit of any purchaser of each adjoining land.

SCHEDULE C

Not to place build construct or erect or permit to be placed built constructed or erected on the land hereby transferred or any part thereof any building that has been built or erected elsewhere and previously used.
