

Applications in rates and charges made to your financial institution or an officer of a Sunshine Coast local government are not accepted for a maximum of 12 months. Please note the Sunshine Coast Council retains the right where a request is deemed to exceed the normal service delivery standard, to provide a maximum of 12 months to deal with the application. If you have queries about the rates and charges due to the council, please contact your financial institution for more information.

**CHANGE OF ADDRESSEES:** Council requires notification of any change of postal address from occupier. When notifying Council in writing, you must include full name and all relevant numbers to which the change relates.

**INTEREST:** From 1 July 2019 to 30 June 2020 interest charges of 11.20% per annum, comprising fully and early to maturity rates and charges, where interest accrued is not received by Council for or before the due date for Payment shown on the Rate Notice interest will apply unless otherwise expressly provided or agreed by Council before the due date for Payment.
